AN ORDINANCE AMENDING ORDINANCE NO. 2993 ADOPTED ON NOVEMBER 28, 2016 ENTITLED "AN ORDINANCE ADOPTING THE BUDGET FOR ALL MUNICIPAL PURPOSES AND USES FOR THE 2017/2018 BIENNIUM "

WHEREAS, On November 28, 2016 City Council adopted Ordinance 2993 establishing the biennial budget for the budget period 2017/2018, and

WHEREAS, state law requires a mid-biennial budget review and modification be conducted before the end of the first year of the biennial budget, which includes a public hearing, and

WHEREAS, On November 6, 2017 City Council reviewed the proposed modification, and on November 13, 2017 City Council held a public hearing on the proposed modification;
